Comparing the Rev. 3 of the Chapeau to the Rev.2

ABOUT:

The Zero Draft of the Pact for the Future was released on January 26th, 2024, marking the start of formal negotiations in preparation for the Summit of the Future (SOTF) scheduled for September 2024. A chapter-by-chapter first reading in early February led to a compilation text, followed by a paragraph-by-paragraph second reading from late February through April. A revised compilation text was then circulated on April 3rd, 2024. To align with the Membership's goal of making the Pact for the Future more concise and action-oriented, Rev.1 was issued on May 14th. The second revision, Rev.2, was subsequently released on July 17th, 2024, followed by the third revision Rev-3 on August 27th, 2024. This bulletin will focus on the Chapeau, comparing Rev-2 and Rev-3 to provide detailed insights.

METHODOLOGY:

This ICH bulletin has compared Rev.3 of the Pact for the Future with Rev.2. The content from Rev.3 and Rev.2 are included in columns 1 and 2, respectively. The third column on "Observations" was written by the Lead Author based on the revised texts and understanding gained by tracking the SOTF negotiations. Direct quotes from the text drafts have been put in quotation marks.

HEADLINES:

- In paragraph 10, the language on "adequate finance" for sustainable development in Rev.2 has been expanded upon in Rev.3 to read "and mobilizing significant financing for developing countries, with special attention to opportunities for young people and the needs of those in special situations".
- In paragraph 11, there has been a new formulation of stronger language on climate change.
- In paragraph 12, the language on peace and security has been strengthened in Rev.3 with the addition of language on "we must abide by international law", "committing to resolve our disputes peacefully, refraining from the threat or use of force or acts of aggression, respecting each-other's sovereignty and territorial integrity, upholding the principles of political





independence and self-determination", and a sentence on "With challenges and risks to international peace and security taking on more dangerous forms, in traditional and new domains, our efforts must keep pace"

- In paragraph 13, the language on human rights has been strengthened with the additions of language on "human rights law", "protections" and "full enjoyment of human rights and dignity", and the formulation "respect, protect, promote and fulfil" human rights. However, reference to "without discrimination" has been deleted in Rev.3.
- Paragraph 14 is a new addition to Rev.3 on reducing inequalities. It reads: "We recognize that our efforts to redress injustice and to reduce inequalities within and between countries to build peaceful, just and inclusive societies cannot succeed unless we step up our efforts to promote tolerance, embrace diversity and combat all forms of discrimination, including racism, racial discrimination, xenophobia and related intolerance and all their abhorrent and contemporary forms and manifestations."
- Paragraph 16 with language on the occasion of the seventy-fifth anniversary of the United Nations has been strengthened with the operative phrase "We reaffirm our pledge".
